create awareness among




# Educational support

# Tarantula spider research



#### **Project Goal**

To fill-up the information gap on the prevalent exploitation and trade of Theraphosid spiders to prevent illegal trade and to bring in attitudinal change among the community in favour of species conservation.

#### **Objectives**

- To sensitize locl communities and stakeholders and to involve them in species conservation through conservation education.
- To obtain a better understanding of the pervasive threats of exploitation and trade of Theraphosid spider.
- To address species and habitat quality decline and to promote conservation
- Dissemination of project results

In 2020-21, during the third year of the project, we worked on two aspects 1. field survey to understand spider distribution and species threats, 2. trail education programmes using educational materials developed exclusively for this by the organization. However, our activities were limited and interrupted due to Covid-19 pandemic. From April 2020 we started an extensive field survey in the study area. The questionnaire survey was completed and data related to illegal spider collection and influence of sociocultural factors on the collection of spiders and species threats. Interviews were conducted among different community representatives such as teachers, villagers (men and women), foresters, panchayat heads, poachers, and any common individual. During the survey, 1100 people were met. Detailed analysis was made from the acquired data. During the spider survey, many *Poecilotheria* spider habitats were newly recorded. Field visits were made for six months this year, as part of the project and during the project period, we travelled around 7300km covering 14 districts alongside of the Western Ghats of Tamil Nadu.







### Community

As part of the spider trade documentation survey, interviews, questionnaire surveys and meetings with village heads were conducted. This gave an insight into the perception of the people about the spider. In general, people have a perception that these spiders are deadly venomous and a spider bite can kill even an elephant, which is not true. There are also many misconceptions existing among the community about the Tiger spider.

#### Research

Tiger spiders are nocturnal. Hence any observation about these spiders in the wild can be carried out only during nighttime. During the day the spider nests will be marked and the behaviour studies of the spiders are done after sunset. This project helped us to locate new distribution range of these spiders.

### **Species Conservation**

Habitat loss and collection from the wild are the two major threats for this species. In the recent past, intentional killing has become a threat. These spiders enter human habitations, especially the males, and they are instantly killed by the people. Through this project education activities, we create awareness not to kill them but to leave them out and let them live. Education plays a major role in the conservation of this species.

# Education programme



After developing the education materials few trial education programmes were conducted. The first trails programme was conducted at Karur in collaboration with Psycho Trust, TN. The programme was attended by 30 youth representing different organizations from Tamil Nadu. Education materials were used to engage the participants through various activities. The active teaching method was adopted. The feedback from the programme was used to finalize the spider education materials required for this project.
